17, 2023. The meeting approved the Proposal on the Issuance of Corporate Bonds. The size of the corporate bonds is no more than RMB 3 billion (including RMB 3 billion). The maturity of the corporate bonds to be issued is not more than 5 years and may be of single maturity variety or a mix of maturities.

The Company has completed the issuance of the first tranche of Technology Innovation Corporate Bond targeted at professional investors.
